- c) Play Area –The play area safety inspection report has high lighted the issue of dog fouling around the childrens play equipment. A quote has been received, and two more are to be sort to fence this area off from the rest of the field and a grant is to be applied for to do this.

The outer fencing of the field is damaged and broken in parts. Proposal to repair these sections.
