a) Accounting statements for period ending 31/05/23 - Ref: 274

Cllr J. Waite questioned whether the cemetery had only been cut once as reflected in the accounts. The clerk advised that the accounts are up to 31st May and are on a receipts & payments basis and therefore only invoices paid are included.
