#### "Dear Residents of North Kelsey,

I just wanted to update you on the situation on West Street, the investigation works order is with LCCs external contractors, I had hoped that this would have been completed by now, sadly that is not the case. I have emailed and chased this issue with the head of highways on 3 separate occasions the latest of which was 12th of June. I would also like to take this opportunity to thank Sir Edward Leigh who assisted myself in my role as your county councillor in ensuring that Anglian Water fulfilled their duties and ensured that their assets are clear and up to scratch. It can be difficult to get a detailed reply from Anglian Water, but as a result of Sir Edward's assistance I managed to get a detailed response on all flooding issues across the local area during the two major storms and heavy rain we have had during this year.

*Please rest assured I will continue to put pressure on all agencies to ensure everything is done that can be to find out what has caused this awful flooding and what can be done to mitigate it."* 

#### The Bards Family – by Cllr D Waite

In Medieval times North and South Kelsey made up a single manor, owned by the Hansard family. In 1539 Elizabeth Hansard married Sir Francis Ayscough who became lord of the manor. The family seat was in Stallingborough, but they also built a large house in South Kelsey, where Hall Farm now stands. Sir Francis was brother to Anne Ayscough (or Askew), a protestant martyr burnt at the stake in London at the time of Henry VIII.

The Bard family had lived in North Kelsey from before 1300, with a record of Adam Bard marrying the daughter of local landowner Richard Daumpere. Five generations later and Thomas Bard married Eleanor, daughter of Sir Richard Hansard of South Kelsey. Their oldest son Ralph was born in North Kelsey in about 1498. In turn he married Ellen Mussenden of Healing.

The oldest son of Ralph and Ellen Bard was William. The Bards were the most important family in North Kelsey, but William's status was very much below that of his cousin Francis, lord of the manor, who had by marriage united the Ayscough's and Hansards.

In 1558, during the first year of the reign of Queen Elizabeth I, William increased his standing by buying from Francis Ayscough the title of Lord of the Manor of North Kelsey. The deed records "Sir Francis Ayscoughe and Elizabeth his wife, to William Barde, of North Kelsey, gent., of manor of North Kelsey (parcel of soke of Caistor) with all appurtenances in North Kelsey, also the Bayhouse Lands in North Kelsey (now in occupation of Thomas Lambert), excepting only such lands as are within the quarter-bailey of South Kelsey, for £280". Although the power that went with the title had declined, a lordship came with authority over common land and the right to charge rents.

The only problem was that Francis Ayscough had split the existing manor in two, allowing him to keep the hall and the title of Lord of the Manor of South Kelsey. Manors regularly changed hands, but no-one had ever tried to divide a title in two, effectively creating a new Manor. The case was of national importance and challenged in court, with the argument made that if this was allowed, lords could split their manors into dozens of smaller plots and sell each one with a new lordship. After several months the arrangement was judged as legal, setting a precedent for the rest of the country.

The new lord, William Bard, married Ellen Middleton of Winteringham in 1562 and it is thought that they lived at what is now Church Farm, opposite the church. The central part of this house dates to the early Tudor period and their great-great-grandson is listed as living there a hundred years later.





When William Bard died in 1582, he was buried in the local church and the title passed to his oldest son, Ralph. Ralph married Margaret Gilby of Stainton in the Hole and they had nine children. Rivalry between the Ayscough and Bard families grew until in 1591 Ralph Bard took Edward Ayscough, son of Francis, to court in a dispute about enclosure of

common land between the two villages. A document survives listing "Edward Ayscough Esquire defendant to the bill of complaint of Ralph Barde gent, John Marris yeoman and others." In return, Edward Ayscough "thinketh that one William Bard father of the said Ralph Barde, John Marrys and diverse others of the freeholders...in North Kelsey about nyne or tenne years more passed did by appointment amongst themselves inclose & pale in... a greate parte of the lande & pasture in north Kelsey aforesaid" and accuses William Bard of being 'mendacious' and 'cunning'.

Ralph Bard's will was written three days before his death in January 1597. In it he states *"I Raulphe Bard of North Kelsey in the countie of Lincolnshire being sick of body but sounde and parfitt of memory thankes be given to Almightie God do make & ordayne this my last will and testament in manner and forme followinge. Fyrst I biquieath and comitt my soule to almightie god my creator In Jesus Christ my redeemer and my body to be buryed in the clossest where my ancestors hath been buryed in North Kelsey church: Item I give and bequeath to the poor people in North Kelsey three shillings fourpence; Item I give and bequeath to the repayringe of the Cathedrall church of Lincoln Three shillings four pence."* 

Ralph's unmarried daughter Magdalyne received £200, his second son John received six pounds, thirteen shillings and four pence to be paid each year during his 'life natural' as well as 'fyftey poundes' while younger siblings William and Edward were given 20 nobles yearly to be paid out of his lands. His daughter Susan and her husband Richard Benson of North Kelsey were gifted £10 each and their child Ralph received £3. Another daughter Elizabeth inherited £10 and her four children by William Marris and Thomas Codd of Caistor twenty shillings each. The last daughter, Anne Baytman, seems to have been less popular and was given half the amount received by her sisters.

The will also throws up a mystery. Ralph's third son, George, was sent to Gray's Inn in London in June 1592. In theory this was to study law, but it was often used as a way for sons of wealthy families to rub shoulders with other gentlemen and become part of London society. London at that time was a thriving port, and home to Queen Elizabeth and William Shakespeare. George, however, vanished. Five years later his father promised *"George Bard my sonne if he be lyvinge shall have twentie nobles Yeerly to be paide unto him out of my landes during his liffe naturall and to enter to it when he shall make himselfe knowne to his brother Thomas Bard that he is lyvinge."* He never claimed the money, and all remaining lands, goods and chattels were bequeathed to his first-born son Thomas.
